this book focuses on the politics of street trees and the institutions actors and processes that govern their planning planting and maintenance this is an innovative approach which is particularly important in the context of mounting environmental and societal challenges and reveals a huge amount about the nature of modern life social change and political conflict the work first provides different historical perspectives on street trees and politics celebrating diversity in different cultures a second section discusses street tree values policy and management addressing more contemporary issues of their significance and contribution to our environment both physically and philosophically it explores cultural idiosyncrasies and those from the point

morland predicts the future of humanity in 10 illuminating statistics could the japanese and italians now go the way of the dodo and looks back to how ebbs and flows of population have shaped history such as the soviet union s plummeting birth rate in the 1960s which hastened the end of the cold war the daily telegraph the best books for summer 2022 the great forces of population change the balance of births deaths and migrations have made the world what it is today they have determined which countries are superpowers and which languish in relative obscurity which economies top the international league tables and which are at best also rans the same forces that have shaped our past and present are shaping our future illustrating this through ten illuminating indicators from the fertility rate in singapore one to the median age in catalonia forty three paul morland shows how demography is both a powerful and an under appreciated lens through which to view the global transformations that are currently underway tomorrow s people ranges from the countries of west africa where the tendency towards large families is combining with falling infant mortality to create the greatest population explosion ever witnessed to the countries of east asia and southern europe where generations of low birth rate and rising life expectancy are creating the oldest populations in history morland explores the geographical movements of peoples that are already under way portents for still larger migrations ahead which are radically changing the cultural ethnic and religious composition of many societies across the globe and in their turn creating political reaction that can be observed from brexit to the rise of donald trump finally he looks at the two underlying motors of change remarkable rises in levels of education and burgeoning food production which have made all these epochal developments possible tomorrow s people provides a fascinating illuminating and thought provoking tour of an emerging new world nobody who wants to understand that world should be without it

while a large number of books have dealt with the navies and war at sea during the world wars the immediate aftermaths have generally received only minimal coverage however the fates of defeated navies are of enormous interest from a number of perspectives these include the relative priorities of the victorious powers acquisition and testing of ex enemy materiel and the intended future capabilities of those ex enemy navies that were to be allowed to continue to exist this new book traces the histories of navies and ships of the defeated powers from the months leading up to the relevant armistices or surrenders through to the final execution of the appropriate post war settlements in doing so it discusses the way in which the victorious powers reached their final demands how these were implemented and to what effect the later histories of ships that saw subsequent service either in their original navies or in those navies which acquired them are also described in doing this much use is made of material drawn from archival and in some cases archaeological sources some of which has never previously been used through these a wide range of long standing myths are busted and some badly distorted modern views and assessments of events in the wake of the conflicts put right the fascinating narrative will be accompanied by tabulated lists of all major navy built and certain significant ex mercantile enemy ships in commission at the relevant date of the armistice or surrender or whose hulks were specifically listed for attention in post second world war allied agreements these will include key dates in their careers and their ultimate fates this highly original book drawing on archaeological evidence as well as archival sources and including numerous photographs will become an essential reference tool for all those interested in the naval history of the two world wars

the 2010 general election was the most eagerly awaited contest in britain since 1997 with opinion polls showing a closing gap between the parties the result was uncertain right up to polling day in the end the election was particularly noteworthy for three reasons first of all there were televised debates between leaders of the three largest parties this idea has long been called for but for a variety of reasons they had not occurred in britain until 2010

now they are here they are almost certainly here to stay secondly the election led to the end of thirteen years of labour rule just as the 1964 and the 1997 elections had delivered the final blows to long standing one party government so 2010 did the same what made 2010 particularly significant however was that unlike 1964 or 1997 no single party assumed the reins of power thirdly although the conservatives ended up as the largest party by some margin they were still some twenty seats short of a majority of just one not since the election of february 1974 had the result failed to produce a majority government in the commons and before that we would have to go back to 1929 to find a similar outcome this book features high quality and data rich examinations of the election it is intended for audiences who want to go beyond a simple description of the election towards an enhanced understanding of why the election turned out the way it did this book was published as a special edition of journal of elections public opinion parties

on the eve of germany s surrender in may 1945 grossadmiral karl dnitz commanded thousands of loyal and active men of the u boat service still fully armed and unbroken in morale enclaves of these men occupied bases stretching from norway to france where cadres of u boat men fought on in ports that defied besieging allied troops to the last at sea u boats still operated on a war footing around britain the coasts of the united states and as far as malaya following the agreement to surrender these large formations needed to be disarmed often by markedly inferior forces and the boats at sea

located and escorted into the harbours of their erstwhile enemies neither side knew entirely what to expect and many of the encounters were tense in some cases there were unsavoury incidents and stories of worse for many allied personnel it was their first glimpse of the dreaded u boat menace and both sides were forced to exercise considerable restraint to avoid compromising the terms of germany s surrender one of the last but most dramatic acts of the naval war the story of how the surrender was handled has never been treated at length before this book uncovers much new material about the process itself and the ruthless aftermath for both the crews and their boats
